The two parties agreed as follows:

Clause 1:

The first party agrees to appoint the second party to work for them as a full- time employee in the position of(Hair Stylist) for a total salary of 8,000 AED being 4,800 AED basic, 1,200 AED accommodation 800 AED transportation and 1,200 AED other allowances.

Clause 2:

The second party undertakes to implement all duties and responsibilities of the job, or any other assignment related thereto.

Clause 3:

The second party shall undergo a 3 months' probation period starting from the date of the contract. The first party may terminate the service of the second party during the probation

period after presenting a two-week notice period in writing that does not require a signature of the second party, and it can be sent via email or to self-phone.

The second party may resign during the probation period after notifying the first party by a similar written notice on the date set for resignation.

During the probationary period, employee is not entitled to receive any benefits such as end of service, flight tickets, paid annual leave and medical insurance.

The second party agreed to pay the cost of employment visa in case of both resignation during probation period in full or to have the cost of the employment visa deducted from his/her remaining salary just before the visa cancelation.

In the event of employment discontinuation or termination during the probationary period, we pay as per number of days employee worked as per calendar.

Upon successful completion of 3 months of continuous employment, the first party may terminate the service of the second party after serving a one-month paid notice period. The second party may resign after notifying the first party by a similar written notice period on the date set for resignation.

- In case of any personal relationships between any of the employees, immediate termination without prior notice will be applied.
- In case of low performance or unacceptable behavior, the below measures are gradually applied:
 1. Verbal Warning.
 2. Written warning to notify the employee that doesn't require the employee's signature.
 3. Written Notice of termination of one-month paid notice period.
- Salary increase will only be based upon performance and hard work. If after salary increment, we noticed poor performance again, the salon has the right to revert the employee back to the initial contract.
- Wearing the uniform is mandatory during working hours and not abiding by that will cause salary deductions.
- Physical appearance is important as we are dealing with clients daily so it is a must to keep your look neat and presentable.

Clause 4:

Working hours are 54 hours per week (6 days per week) and rest day will be during the weekday that is not busy for the business.

Clause 5:

You will be entitled to a one (1) month or 30 days paid leave salary every year plus the amount of equivalent of the economy class air ticket allowance to your home country of origin every year after proof of reservation with a maximum amount of 2,000. AED.

Clause 6:

Hair Creators Salon Ltd. shall provide basic medical insurance for you under a private medical scheme.

Clause 7:

During your employment, you must not carry out any other employment or business relating or not relating to our field of work with another person or company with or without pay.
