As you know the purpose of the loan for us was to add additional services in our salon, after the loan was approved and credited into our account, we have signed 3 pay cheques for the Fit-Out contractor and two more suppliers as per the quotations we sent you during the loan application process and as per agreement with rak bank.

We never expect all the current delay to happen from The POS company and from ADIB bank in issuing the requested "POS assignment letter" as it takes up to 2 weeks from Adib to be issued after the submission which was last Wednesday as per the emails I shared with you earlier.
