However, it's been 3 months since I signed the POA to your office and until today you didn't even notified the court that you're my legal representative and till the moment you didn't at least prepare a draft copy of any memorandum of defense!!

I expect a logical explanation from your side by tomorrow and a submission of the mentioned documents at the court portal by Tuesday morning or else I am left with no option but to terminate our contract and seek a refund.
